

Environment Management Policy of Daehan Solution



[Overview]

1. Purpose of Enactment

Daehan Solution has enacted this Environment Management Policy in order to create the sustainable future by minimizing any negative environmental effect that can be generated in the process of production and sale of products and fulfilling its social responsibilities.

2. Scope of Application

Daehan Solution shall apply this Environment Policy to domestic and overseas workplaces, subsidiaries and affiliates, and encourage its subcontractors and all other business partners to comply with this Policy: Provided, that where this Policy is in conflict with the laws of the relevant country, the laws of the relevant country shall apply with priority.

[Basic Policy]

1. Efficient Use of Raw and Subsidiary Materials

Daehan Solution shall minimize unnecessary waste of natural resources through efficient use of raw and subsidiary materials put into production of products, and minimize negative effect on the environment by managing to ensure that natural resources are not illegally damaged or environmental pollution is not generated in the process of acquisition of raw and subsidiary materials.

2. Efficient Use of Energy

Daehan Solutions shall maximize the energy efficiency of the production facilities, minimize waste of energy by introducing facilities with high energy efficiency, and push ahead with eco-friendly energy use that can fundamentally cut off generation of greenhouse gas following energy use.

3. Efficient Use of Water

Daehan Solution shall continuously push ahead with the activities to reduce water usage and wastewater, minimize environmental pollution and maximize water saving through introduction of wastewater recycling facilities and system.

4. Reduction of Greenhouse Gas

Daehan Solution shall recognize environmental problems such as climate change caused by greenhouse gas and sets up and actively push ahead with the working plan to minimize such effect. To this end, we will push ahead with systematic management and reduction of emission of



greenhouse gas by participating in voluntary programs related to climate.

5. Minimization of Waste Generation

Daehan Solution shall push ahead with the activities to fundamentally reduce waste generation, and endeavors to develop technology to minimize environmental effect by recycling the generated wastes. In addition, it shall push ahead with the activities to minimize environmental effect at the disposal state such as incineration of wastes or landfill of wastes, etc. in collaboration with waste businesses.

6. Management of Environmental Pollution and Harmful Substance

Daehan Solution shall do its utmost to minimize environmental effect by minimizing air and water pollutants and to protect safety and health of employees. In addition, Daehan Solution shall identify the current status of harmful chemical substances contained in the products, provide necessary information to the interested parties, and establishes and implement harmful substance management policy including reduction of use and management of risk of harmful substances, etc.

7. Biodiversity Protection

Daehan Solution shall establish and implement policies to protect biodiversity in the purchase and procurement of raw materials and throughout the whole business. In addition, Daehan Solution shall endeavor to establish implementable measures to protect biodiversity in the overall process of business operations such as product distribution, sales, and waste recycling technology development.

[Environment Management System]

1. Management System

Daehan Solution shall operate the highest decision-making body that makes important decisions related to environment management including setting of strategies and guidelines for environment management and goals of environment management, and a working group participated in by various departments for working-level discussion for direction for improvement of environment management and discovery of tasks for practice, discovery and assessment of indicators for environment management, and any other issues of environment management.

2. Risk Assessment

Daehan Solution shall establish the environment risk assessment system that identifies, assesses and delivers to the management the environmental risk that may cause environment issues, and if necessary, it may utilize any outside independent risk assessment institution to assess the



environment risk.

3. Development of Indicators

Daehan Solution shall objectively manage the performance of environment management by developing and continuously measuring the indicators that can assess the result of the environment management activities, and cause environment management to be effectively promoted by connecting with the internal performance system.

4. Disclosure of Result

Daehan Solution shall share the information related to environment management via the Company homepage, etc. for the interested parties to verify, and will actively collect various demands and opinions of the interested parties and reflect them in the environment management activities. Overseas corporations will translate the reports into their local languages so that the local government, companies and business partners can verify them.

- 2. Actively endeavor for sustainable use of resources and energy and reduction of pollutants across the overall process of development, production, sale, use and discarding of products.

- 6. Transparently reveal the result of environment management to the company members and interested parties in various ways.
- 7. Regularly implement environmental education for all employees, support environment management activities of subcontractors, and endeavor to enhance the social awareness towards environment.
